COUNTY QUESTIONS

PROPOSITION NO. 1

Shall Lincoln County, Oklahoma form an Emergency Medical Service District, composed of all of Lincoln County, and levy a special annual recurring ad valorem tax of three (3) mills on the dollar of assessed valuation, in addition to all other levies, upon the assessed valuation of all taxable property in Lincoln County, real and personal, under the authority of Article X, Section 9C of the Oklahoma Constitution, for the purpose of providing funds for the support, organization, operation and maintenance of said District, said levy to be effective in the 2021 Tax Year and thereafter until lawfully repealed, be approved?

PROPOSITION NO. 2

Shall Lincoln County, Oklahoma incur indebtedness pursuant to Article X, Section 35 of the Oklahoma Constitution by issuing its general obligation limited tax bonds in the principal amount of not to exceed Thirteen Million Five Hundred Thousand Dollars (\$13,500,000), to be issued serially in one or more series to provide funds for acquiring real property, if necessary, and designing, constructing, equipping, furnishing, and maintaining a new Lincoln County Jail and other improvements related thereto, to be completed with or without use of other available funds, and levying and collecting an annual ad valorem tax in addition to all other ad valorem taxes upon all taxable property in Lincoln County sufficient to pay interest on such bonds as it falls due and also to constitute a sinking fund for the payment of the principal thereof when due, said additional ad valorem tax not to exceed Five (5) mills on the dollar, said bonds to bear interest at a rate not to exceed Ten Percent (10%) per annum, payable semi-annually and to become due serially no later than Thirty (30) years from their date?
