Commissioner Lee Doolen called the meeting to order at 9:01 A.M. Commissioner's Marlon Miller and Will Fine was absent.

Fine led prayer and Doolen led flag salute.

No Citizen Comments.

Travis Ohnemus with Ascend Construction updated the Commissioners on the lighting change to be made in 170 and 178 of the Jail renovation. The original specifications did not have the correct lighting listed and will cost \$18,080.70 to upgrade to detention grade light at a future meeting. If the proposed dorm room Change Order is not approved, they will still have to change the lighting plans at about half that cost. Miller made a motion to approve Change Order 15 for Dorm 170/178 to incorporate a dorm in place of the previous video conference room for \$71,137.00. Motion seconded by Fine. Doolen, Miller and Fine all voted aye.

County Clerk Alicia Wagnon and HR Generalist Melanie McFee updated the Commissioner from the meeting they had with OPEH&W regarding the special assessment fee of \$159,647.92. OPEH&W stated that our claims are down 16% but they need cash flow due to counties paying in arrears so they can catch up on claim payments. The total fee for all the counties and municipalities was \$5 million with our share cost of 3.19% based on premiums paid. Wagnon reached out to the Insurance Commission, and they don't regulate surcharge cost but said this was unheard of. Fine has reached out to Senator Grant Green as well. The fee is due immediately regardless of whether we stay with them or shop for new coverage. President Ross has been unable to provide a copy of the contract with the County but has offered to meet with the Commissioner to discuss. Doolen does not want to meet unless they can provide them with the contract and suggested looking at other numbers. 911 previously talked to BancFirst and he would like to see their offer. Fine wished they had some regulation but concerned with switching. Miller wants to know if the money is going to get them ahead will the money come back to us if we switch. March 17, 2026 is the cutoff date to answer regarding payment or payment plan of 3 monthly payments before the end of the Fiscal Year. No Action at this time until they are able to review the contract.

Miller made a motion to let bids for used pick-up in District #2. Motion seconded by Fine. Doolen, Miller and Fine all voted aye.

Miller made a motion to approve Declaration of Surplus for District #3.
