## County Commissioner's Meeting October 24<sup>th</sup>, 2022

Lee Doolen called the meeting to order at 9:12 a.m. Carl Munson was also present. Marlon Miller was absent.

Will Fine led prayer and Lee Doolen led flag salute.

Munson made a motion to approve minutes from the October 3<sup>rd</sup>, 2022 meetings. Motion seconded by Doolen. Doolen and Munson voted aye.

No action was taken to open Bid # 23-03 for the sale of County Fair Surplus items.

Doolen made a motion to approve purchase and placement of steel rated grates for the sidewalk north of the courthouse. McCommas gave a quote of \$5,3000.00. Motion seconded by Munson. Doolen and Munson voted aye.

Ross Sestak from the OSU Extension Office requested funding from the ARPA funds for a new OSU Extension Office Building at the County Fairgrounds. The new building would be 9,600 sq. ft. total with a 4,400 sq. ft. conference area, 5 office spaces, bathrooms and a kitchen space. They are asking for \$1.8 million for a turn-key facility. No action was taken to approve this but it will be considered.

The Sheriff's office is interested in installing panic buttons throughout the courthouse. Wave Plus Systems provided a quote of \$11,365.00 for 14 panic buttons, control panel and onsite set-up and training. Doolen made a motion to approve the purchase through the Courthouse Improvement Fund. Motion seconded by Munson. Doolen and Munson voted aye.

No action was taken to purchase new scales for the Size and Weights Program in the Sheriff's Office.

Munson made a motion to approve payment of Sheriff's Vehicle claim from the ACCO Deductible Fund. The other party's insurance should reimburse the ACCO Deductible Fund. Motion seconded by Doolen. Doolen and Munson voted aye.

No action was taken to review and discuss employee incident and accident reports.

Munson made a motion to deny early payroll in November. Motion seconded by Doolen. Doolen and Munson voted aye.

The Commissioners discussed Supplemental Pay for January 2023. Supplemental pay will allow the county to change the pay period so that paid time is worked prior to approving and running payroll. A Use Tax Resolution will be prepared for discussion at a future meeting.

Doolen made a motion to approve Floyd & Driver Legal Services Agreement for the administration of the County's ARPA funds. Motion seconded by Munson. Doolen and Munson voted aye.

No action was taken to approve ARPA funded projects.

No action was taken to approve OMMA funded projects.

Doolen made a motion to approve a Use Tax Resolution for contractor pay to the County grant writer. Motion seconded by Munson. Doolen and Munson voted aye.

Munson made a motion to approve four (4) Interstate 40 Crosstown Steel Beam Transfer forms. Motion seconded by Doolen. Doolen and Munson voted aye.

Emergency Management and Floodplain Update – Cody McDonell reported that they had opened Emergency Management Operations for a fire response exercise.

He also made a presentation to the Sales Tax Advisory Committee and requested an extra ½ % of the 1¢ sales tax.

No action was taken to extend the burn ban for Lincoln County.
