Miller made a motion to approve the Close-out of Fiscal Year 24-25 Opioid Abatement Grant. Out of the \$150,000.00 received to support prevention, recovery, treatment coordination and community collaboration to address substance use disorders we spent \$120,391.09 with \$29,608.91 being returned. No Action regarding Lincoln County Fairgrounds exterior project Change Order.

- \$750,000.00 transferred from General Government Full Time Salary to General Government Capital Outlay.
