
MINUTES OF THE LINCOLN COUNTY ELECTION BOARD MEETING AUGUST 27, 2024


The Lincoln County Election Board met in a regular meeting at 4:00 p.m. at the Election Board Office, Suite 15, Lincoln County Courthouse, 811 Manvel Ave., Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on December 1, 2023, at 9:40 a.m. and by posting an agenda at the County Election Board office on August 12, 2024, at 3:50 p.m. One copy of the notice and one of the agenda is attached.


The following members were present: Anthony Perna, James Marak, Melissa Stambaugh.
BUSINESS CONDUCTED AT THE MEETING

1. CALL TO ORDER by Marak at 4:00 p.m.
2. ROLL CALL by Stambaugh: Perna, aye; Marak, aye; Stambaugh, aye; All members present.
3. BUSINESS CONDUCTED: Discussion and approval of minutes of the August 24, 2024, special meeting. Motion by Perna, second by Stambaugh, minutes be approved. Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
4. BUSINESS CONDUCTED: Process absentee ballots for the August 27, 2024, Runoff Primary Election. After opening the outer envelopes and examining the affidavits, the Board determined that a total of 12 absentee ballots were sufficient to count. ACTION TAKEN: Motion by Perna, 2nd by Stambaugh to count 12 ballots. Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0. It was found that 2 affidavits were insufficient to count. Motion by Perna, second by Stambaugh to reject 2 affidavits for no signature date. Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
5. BUSINESS CONDUCTED: Recess Meeting, if needed. ACTION TAKEN: Motion by Perna, 2nd by Stambaugh to recess meeting at 5:00 p.m. and reconvene at 6:45 p.m. Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0. The meeting was reconvened to 6:45 p.m.
6. BUSINESS CONDUCTED: Canvass returns. Board members were present and participated in the receipt of voting devices, election supplies and transfer boxes with ballots from inspectors; the tabulation of election results and production of tabulation reports and summary results reports; and the transfer of transfer boxes to the sheriff for security were placed in the secure vault. Canvassing of the Runoff Primary August 27, 2024, Election Returns for state and county offices were reviewed by the board. ACTION TAKEN: None. Board action not required.
7. BUSINESS CONDUCTED: Canvas returns of the August 27, 2024, special election results for 2 propositions for the Town of Davenport. ACTION TAKEN: None. Board action not required.
8. BUSINESS CONDUCTED: Canvas returns of the August 27, 2024, special election results for 1 proposition for Wellston School District I-4. ACTION TAKEN: None. Board action not required.

9. **BUSINESS CONDUCTED:** Canvas returns of the August 27, 2024, special election results for 2 propositions for Paden School District I-14 to Okfuskee County.

10. **BUSINESS CONDUCTED:** Canvas returns of the August 27, 2024, special election results for 2 propositions for McLoud School District I-1 to Pottawatomie County.

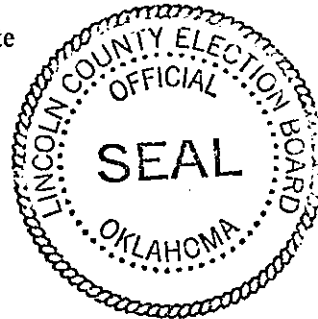
