The Lincoln County Election Board met in a regular meeting at 3:00 p.m. at the Lincoln County Election Board office, Suite 15, Lincoln County Courthouse, 811 Manvel Ave., Chandler, Oklahoma. Advance notice of the meeting was performed by filing a written notice with the County Clerk on December 1, 2024, at 9:40 a.m., and by posting an agenda at the County Election Board office on August 28, 2024, at 12:05 p.m. One copy each of the notice and agenda is attached.


The following members were present: Anthony Perna, James Marak, Melissa Stambaugh.

For a lack of quorum, the meeting did not convene until 3:30 p.m.


BUSINESS CONDUCTED AT THE MEETING





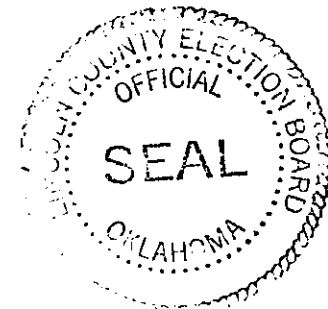
