OF THE LINCOLN COUNTY ELECTION BOARD MEETING

NOVEMBER 2, 2024

The Lincoln County Election Board met in special meeting at 1:00 p.m. at the Commissioner Meeting Room, Lincoln County Courthouse, Ste. 4, Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on September 10, 2024, at 1:29 p.m. and by posting an agenda at the County Election Board office on October 21, 2024 @ 4:30 p.m. One copy of the notice, one copy of the agenda and one copy of the document giving authority to meet early is attached.

The following members were present: Anthony Perna, James Marak, Melissa Stambaugh.

BUSINESS CONDUCTED AT THE MEETING

- For lock of quorum, the meeting was not called to order until 1:29 p.m. Member present were Anthony Perna and James Marak. Melissa Stambaugh joined the meeting at 2:00 p.m.
- 2. BUSINESS CONDUCTED: Discussion and approval of minutes of the August 30, 2024, Regular Meeting. ACTION TAKEN: Motion by Perna, seconded by Marak, minutes approved. ROLL CALL VOTE: Marak, aye; Perna, aye. Motion passed 2 0.
- 3. BUSINESS CONDUCTED: Process mail and absentee ballots submitted for the November 5, 2024, election, including opening the outer envelope, opening the secrecy envelope, processing the ballots through the escan voting device and suspending the polls until November 5, 2024, regular meeting. After opening and examining the absentee ballots, we found 465 affidavits that were sufficient to count, which contained 913 total ballots. We found a total of 19 affidavits that were tabled until the next meeting. Motion by Perna, seconded by Marak to count 913 absentee ballots and table the 19 affidavits until the next meeting. ROLL CALL VOTE: Marak, aye; Perna, aye; Stambaugh, aye. Motion passed 3 0.

4. Motion to adjourn by Perna, second by Marak. ROLL CALL VOTE: Marak, aye; Perna, aye; Stambaugh, aye. Motion passed 3 – 0. The meeting was adjourned at 9:12 p.m.
