MINUTES OF THE LINCOLN COUNTY ELECTION BOARD MEETING APRIL 5, 2024


The Lincoln County Election Board met in a regular meeting at 3:30 p.m. at the Election Board Office, Lincoln County Courthouse, Ste. 15, Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on December 1, 2023, at 9:40 a.m. and by posting an agenda at the County Election Board office on April 3, 2024, at 11:00 a.m. One copy of the notice and one of the agenda is attached.

The following members were present: Anthony Perna, James Marak, Melissa Stambaugh.

BUSINESS CONDUCTED AT THE MEETING

1. The meeting was called to order at 3:30 p.m. Roll Call taken; all members present listed above.






