## OF THE LINCOLN COUNTY ELECTION BOARD MEETING JUNE 18, 2024

The Lincoln County Election Board met in a regular meeting at 4:00 p.m. at the County Election Board, Suite 15, Lincoln County Courthouse, 811 Manvel Ave., Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on December 1, 2023, at 9:40 a.m. and by posting an agenda at the County Election Board office on June 11, 2024, at 8:40 a.m. One copy of the notice and one of the agenda is attached.

The following members were present: Anthony Perna, James Marak, Melissa Stambaugh.

### BUSINESS CONDUCTED AT THE MEETING

1. Called to order with roll call at 4:11 p.m. All the members were present.
2. BUSINESS CONDUCTED: Discussion and approval of minutes of the June 15, 2024, special meeting. Motion by Perna, second by Stambaugh, minutes be approved. ROLL CALL VOTE: Marak, aye; Perna, aye; Stambaugh, aye. Motion passed 3-0.
3. BUSINESS CONDUCTED: Processed the additional absentee mail and nursing home ballots received after the special meeting on June 15, 2024, for the June 18, 2024, Primary Election. After opening the outer envelopes and examining the affidavits for sufficiency, the board determined that a total of nine ballots should be counted. ACTION TAKEN: Motion by Perna, 2<sup>nd</sup> by Stambaugh to count nine ballots that were found sufficient. ROLL CALL VOTE: Marak, aye; Perna, aye; Stambaugh, aye; Motion passed 3-0. The board observed the counting of the ballots by the voting device.
4. Motion by Perna to recess meeting and reconvene at 6:45 p.m., second by Stambaugh. ROLL CALL VOTE: Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0. The meeting was reconvened at 6:45.
5. BUSINESS CONDUCTED: Canvass all Absentee and Precinct returns for all federal, state and county offices for the June 18, 2024, Primary Election. Board members were present and participated in the receipt of voting devices, election supplies and transfer boxes with ballots from inspectors, the tabulation of election results and production of tabulation reports, summary results and the unofficial certification reports. The sheriff took control of transfer boxes for security and were placed in the election board's secure vault. The June 18, 2024, Primary Election Returns were reviewed and canvassed by the board. ACTION TAKEN: None. Board action not required.
6. Perna motioned to adjourn the meeting and Stambaugh 2<sup>nd</sup> the motion. ROLL CALL VOTE: Marak, aye; Perna, aye; Stambaugh, aye. Motion passed. 3-0. Meeting adjourned at 8:27 p.m.


