## MINUTES OF THE LINCOLN COUNTY ELECTION BOARD MEETING AUGUST 8, 2023


The Lincoln County Election Board met in a special meeting at 6:00 p.m. at the Election Board Office, Lincoln County Courthouse, Ste. 15, Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on June 5, 2023, at 3:56 p.m. and by posting an agenda at the County Election Board office on July 26, 2023, at 11:11 a.m. One copy of the notice and one of the agenda is attached.


The following members were present: Kenneth Kinnear (Alternate), Anthony Perna, Melissa Stambaugh.

### BUSINESS CONDUCTED AT THE MEETING

1. The meeting was called to order at 6:01 p.m. Roll Call taken; members present listed above.
2. **BUSINESS CONDUCTED:** Discussion and approval of minutes of the July 14, 2023, special meeting. **ACTION TAKEN:** Motion by Stambaugh, second by Kinnear, minutes be approved. **ROLL CALL VOTE:** Perna, aye; Kinnear, aye; Stambaugh, aye. Motion passed 3-0.
3. **BUSINESS CONDUCTED:** Process mail and nursing home absentee ballots submitted for the August 8, 2023, election.
