
MINUTES OF THE LINCOLN COUNTY ELECTION BOARD MEETING JANUARY 5, 2022




The following members were present: Anthony Perna, James Marak, Melissa Stambaugh, Call to order at 3:00.

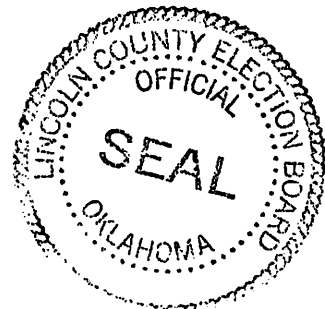



ORDER ESTABLISHING PRECINCT BOAUNDARIES


LINCOLN COUNTY ELECTION BOARD



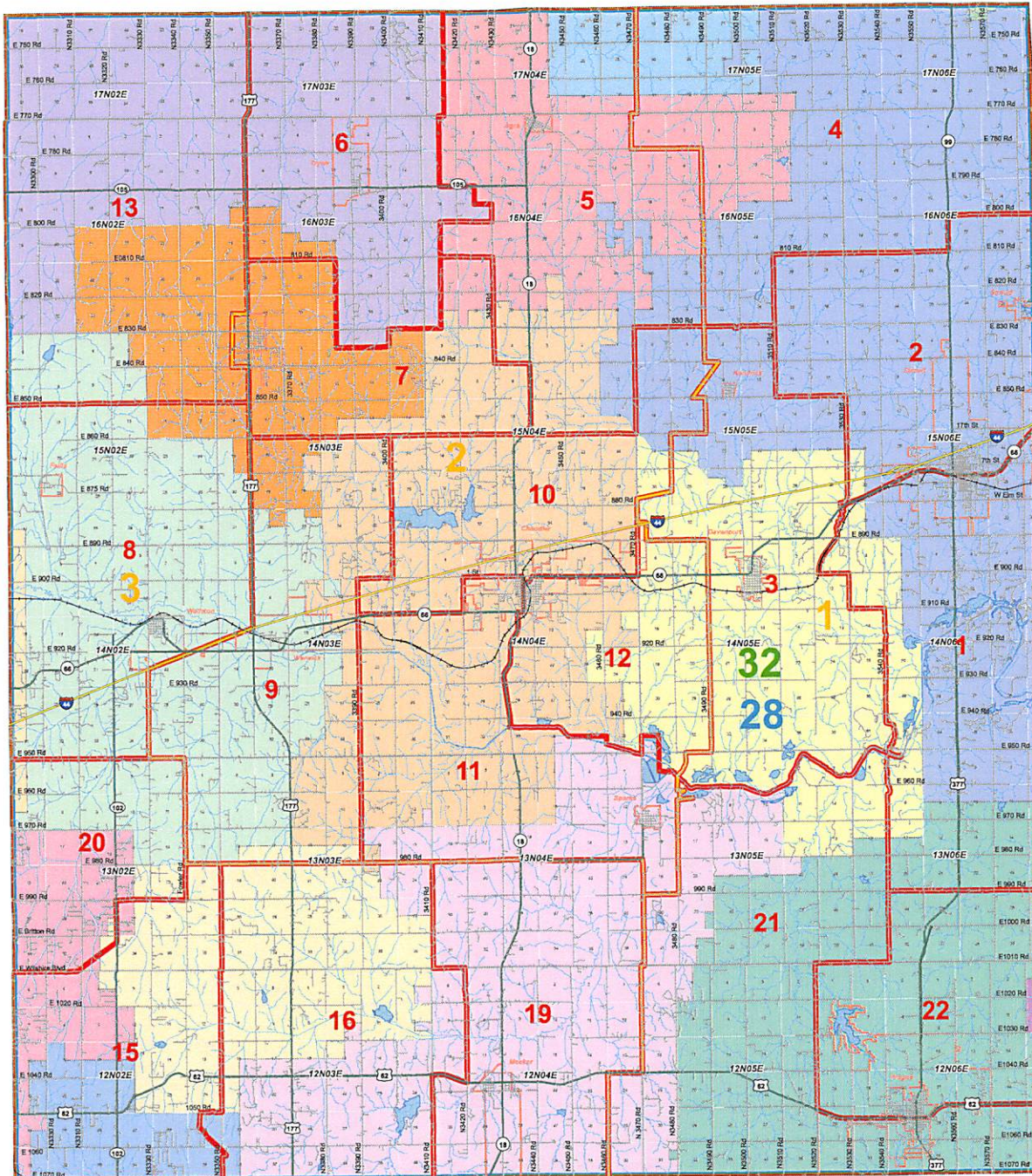
