Advance public notice of the meeting was performed by filing a written notice with the County Clerk on December 9, 2021, at 8:40 a.m. and by posting an agenda at the County Election Board office on January 31, 2022, at 9:45 a.m. One copy of the notice and one of the agenda is attached.

The following members were present: Anthony Perna, James Marak, Melissa Stambaugh.

#### BUSINESS CONDUCTED AT THE MEETING

- 1. Meeting was called to order at 5:46 p.m. for lack of quorum at 5:00 p.m. Roll Call taken; all members present at that time.
