The Lincoln County Election Board met in a regular meeting at 4:00 p.m. at the Election Board Office, Suite 15, Lincoln County Courthouse, 811 Manvel Ave., Chandler, Oklahoma. Advance notice of the meeting was performed by filing a written notice with the County Clerk on December 3, 2025, at 12:07 p.m., and by posting an agenda at the County Election Board office on January 26, 2026, at 11:00 a.m. One copy each of the notice and agenda is attached.


1. CALL TO ORDER by Anthony Perna at 4:01 p.m.




