

**MINUTES

FEBRUARY 13, 2026**

The Lincoln County Election Board met in a regular meeting at 3:30 p.m. at the Lincoln County Election Board office, Suite 15, Lincoln County Courthouse, 811 Manvel Ave., Chandler, Oklahoma. Advance notice of the meeting was performed by filing a written notice with the County Clerk on December 03, 2025, at 12:07 p.m., and by posting an agenda at the County Election Board office on February 11, 2026, at 12:45 p.m. One copy each of the notice and agenda is attached.

The following members were present: Anthony Perna and Dena Jo Bromley.

The meeting was called to order by Anthony Perna.

BUSINESS CONDUCTED AT THE MEETING

1. Meeting was called to order at 3:30 p.m.
2. Roll Call taken: Anthony Perna and Dena Jo Bromley were present.
3. **BUSINESS CONDUCTED:** Discussion and approval of minutes of the February 10, 2026, regular meeting. **ACTION TAKEN:** Motion by Bromley, second by Perna, minutes approved. **ROLL CALL VOTE:** Perna, aye; Bromley, aye. Motion passed 2-0.

Motion passed 2-0.
