The Lincoln County Election Board met in a regular meeting at 3:30 p.m. at the Lincoln County Election Board office, Suite 15, Lincoln County Courthouse, 811 Manvel Ave., Chandler, OK. Advance notice of the meeting was performed by filing a written notice with the County Clerk on December 2, 2024, at 9:01 a.m., and by posting an agenda at the County Election Board office on February 12, 2025, at 1:53 p.m. One copy of each of the notice and agenda is attached.


The following members were present: James Marak, Anthony Perna, Dena Jo Bromley.


The meeting was called to order by James Marak.


### BUSINESS CONDUCTED AT THE MEETING

1. Meeting was called to order at 3:37 p.m.
2. Roll Call taken; all members were present.
