
## **MINUTES OF THE LINCOLN COUNTY ELECTION BOARD MARCH 4, 2025**



Advance notice of the meeting was performed by filing a written notice with the County Clerk on December 2, 2024, at 9:01 a.m., and by posting an agenda at the County Election Board office on February 20, 2025, at 3:15 p.m. One copy each of the notice and agenda is attached.


The following members were present: James Marak, Anthony Perna, Dena Jo Bromley.

### **BUSINESS CONDUCTED AT THE MEETING**

1. Meeting was called to order at 5:02 p.m.
2. Roll Call taken: all members were present.
3. BUSINESS CONDUCTED: Discussion and approval of minutes of the February 14, 2025, regular meeting. ACTION TAKEN: Motion by Perna, second by Bromley, minutes approved ROLL CALL VOTE: Marak, aye; Perna, aye; Bromley, aye. Motion passed 3 – 0.






