MINUTES OF THE LINCOLN COUNTY ELECTION BOARD JUNE 16, 2026

The Lincoln County Election Board met in a regular meeting at 2:05 p.m. at the Election Board Office, Suite 15, Lincoln County Courthouse, 811 Manvel Ave., Chandler, Oklahoma. Advance notice of the meeting was performed by filing written notice with the County Clerk on December 3, 2025, at 12:05p.m., and by posting an agenda at the County Election Board office on May 5, 2026, at 9:00 a.m. One copy each of the notice and agenda is attached.


The following members were present: Virgil Wilson, Anthony Perna, Dena Jo Bromley.

BUSINESS CONDUCTED AT THE MEETING


1. CALL TO ORDER by Virgil Wilson at 2:05 p.m.
2. ROLL CALL by Bromley: Wilson, aye; Perna, aye, Bromley, aye. All members present.
3. BUSINESS CONDUCTED: Discussion and approval of minutes of the April 10, 2026, Regular Meeting. ACTION TAKEN: Motion by Perna, 2nd by Wilson, minutes to be approved. ROLL CALL VOTE: Wilson, aye; Perna, aye; Bromley, aye. Motion passed 3-0.
4. BUSINESS CONDUCTED: Process absentee ballots for the June 16, 2026, Primary Election, State Question No. 832 election, and the City of Prague Special Election. After opening the outer envelopes and examining the affidavits, the Board determined that a total of 115 ballots out of 130 ballots were sufficient to count. ACTION TAKEN: Motion by Perna, 2nd by Wilson to count the 115 ballots. ROLL CALL VOTE: Wilson, aye; Perna, aye; Bromley, aye. Motion passed 3-0. It was determined that 15 ballots were insufficient for the following reasons: 1 ballot – ‘Affidavit Not Notarized’, 1 ballot – ‘Affidavit Not Returned’, and 13 ballots – ‘Affidavit Incomplete’.
5. BUSINESS CONDUCTED: Recess meeting until 6:45 p.m. ACTION TAKEN: Motion by Wilson, 2nd by Perna to recess meeting until 6:45 p.m. ROLL CALL VOTE: Wilson, aye; Perna, aye; Bromley, aye. Motion passed 3-0.
6. BUSINESS CONDUCTED: Canvass returns. Board members were present and participated in the receipt of voting devices, election supplies and transfer boxes with ballots from inspectors; the tabulation of election results and production of tabulation reports and summary results reports; and the transfer of ballot boxes to the sheriff for security were placed in the secure vault. Canvassing of the June 16,

2026, State of Oklahoma's Federal and State Primary Election. ACTION TAKEN: None, Board action not required.


7. BUSINESS CONDUCTED: Canvass returns for the State of Oklahoma's State Question No. 832. ACTION TAKEN: None, Board action not required.

10. BUSINESS CONDUCTED: Adjourn Meeting. ACTION TAKEN: Perna motioned to adjourn the meeting, 2nd by Wilson. ROLL CALL VOTE: Wilson, aye; Perna, aye; Bromley, aye. Motion passed 3-0. The meeting was adjourned at 9:04 p.m.


