MINUTES OF THE LINCOLN COUNTY ELECTION BOARD MEETING JULY 13, 2021

The Lincoln County Election Board met in a special meeting at 4:00 p.m. at the Election Board Office, Lincoln County Courthouse, Ste. 15, Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on May 27, 2021, at 9:20 a.m. and by posting an agenda at the County Election Board office on July 6, 2021, at 9:00 a.m. One copy of the notice and one of the agenda is attached.

The following members were present: Anthony Perna, James Marak, and Melissa Stambaugh.

BUSINESS CONDUCTED AT THE MEETING


1. **CALL TO ORDER** at 4:00 p.m. **ROLL CALL** taken. All were present shortly after 4:00.
2. **BUSINESS CONDUCTED:** Discussion and approval of minutes of the April 9, 2021, regular meeting. **ACTION TAKEN:** Motion by Marak, second by Stambaugh, minutes be approved. **ROLL CALL VOTE:** Perna, aye; Marak, aye; and Stambaugh, aye. Motion passed 3-0.
3. **BUSINESS CONDUCTED:** Discuss and Approve list of inspectors who have resigned. See attached list. Motion by Marak, second by Perna to accept the inspector's resignations. **ROLL CALL VOTE:** Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
4. **BUSINESS CONDUCTED:** Process mail and nursing home absentee ballots submitted for the July 13, 2021, special election. After opening and examining the absentee ballots, we found three to be rejected. Motion by Stambaugh, second by Marak to reject three absentee affidavits, one for lack of witnesses, one for no signature, and one for insufficient information. **ROLL CALL VOTE:** Perna, aye; Marak, aye; and Stambaugh, aye. Motion passed 3-0. Motion by Stambaugh, second by Perna for board to remake ballot for mailed in email ballot. **ROLL CALL VOTE:** Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0. Motion by Perna, second by Marak to approve a total 66 Ballots to be counted. **ROLL CALL VOTE:** Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
5. Motion to recess meeting. Motion by Marak, second by Perna to recess meeting until 6:45. **ROLL CALL VOTE:** Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0. Meeting was reconvened at 6:45.

6. **BUSINESS CONDUCTED:** Board members were present and participated in the receipt of voting devices, election supplies and ballots from inspectors; the tabulation of election results and production of tabulation reports and summary results reports; and the transfer of transfer boxes to the sheriff for security.

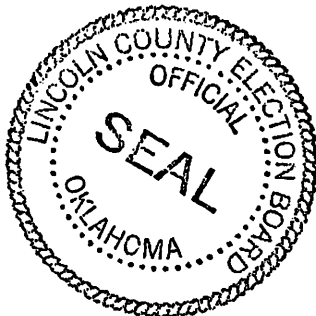


