MINUTES OF THE LINCOLN COUNTY ELECTION BOARD AUGUST 25, 2026

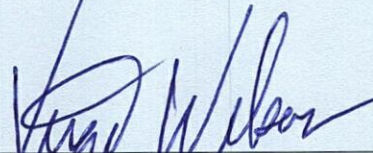
The Lincoln County Election Board met in a regular meeting at 4:07 p.m. at the Election Board Office, Suite 15, Lincoln County Courthouse, Chandler, Oklahoma. Advance notice of the meeting was performed by filing a written notice with the County Clerk on December 3, 2025, at 12:05 p.m., and by posting an agenda at the County Election Board office on July 1, 2026, at 3:32 p.m. One copy each of the notice and agenda is attached.

The following members were present: Virgil Wilson, Anthony Perna, Dena Jo Bromley.

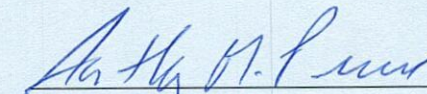
BUSINESS CONDUCTED AT THE MEETING

1. CALL TO ORDER by Wilson at 4:07 p.m.
2. ROLL CALL by Bromley: Wilson, aye; Perna, aye; Bromley, aye.
3. BUSINESS CONDUCTED: Discussion and approval of minutes of the June 19, 2026, regular meeting. ACTION TAKEN: Motion by Perna, second by Wilson, minutes to be approved. ROLL CALL: Wilson, aye; Perna, aye, Bromley, aye. Motion passed 3.0.
4. BUSINESS CONDUCTED: Process absentee ballots for the August 25, 2026, Federal, State, and County Primary Runoff Election, Town of Tryon's OG&E Special Election, and Carney School (I-105) Special BOE's Election, Office No. 3 unexpired term. After opening the outer envelopes and examining the affidavits, the Board determined that a total of 127 of the 136 ballots were sufficient to count. It was decided that 9 affidavits were insufficient and were rejected. ACTION TAKEN: Motion by Perna, second by Wilson, to accept 127 absentee ballots. ROLL CALL: Wilson, aye; Perna, aye, Bromley, aye. Motion passed 3.0.
5. BUSINESS CONDUCTED: Recess meeting. ACTION TAKEN: Motion by Perna, second by Wilson, to recess the meeting and reconvene at 7:00 p.m. ROLL CALL: Wilson, aye; Perna, aye, Bromley, aye. Motion passed 3.0.
6. BUSINESS CONDUCTED: Canvass returns. Board members were present and participated in the receipt of voting devices, election supplies and transfer boxes with ballots from inspectors; the tabulation of election results and production of tabulation reports and summary results reports; and the transfer of the transfer boxes to the sheriff for security were placed in the secure vault. Canvassing of the Runoff Primary August 25, 2026, Election Returns for federal, state and county offices were reviewed by the board. ACTION TAKEN: None. Board action is not required.

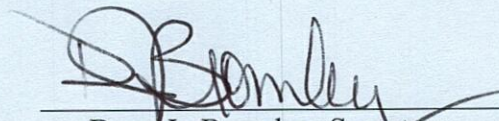

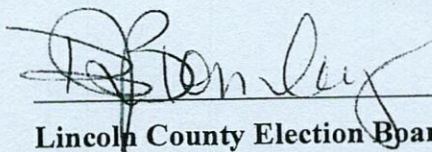
