# MINUTES OF THE LINCOLN COUNTY ELECTION BOARD MEETING AUGUST 20, 2022

The Lincoln County Election Board met in a special meeting at 1:00 p.m. at the Commissioner's Meeting Room, Suite 4, Lincoln County Courthouse, 811 Manvel Ave., Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on July 27, 2022, at 9:20 a.m. and by posting an agenda at the County Election Board office on August 12, 2022, at 10:45 p.m. One copy of the notice and one of the agenda is attached. The following members were present: Anthony Perna, James Marak, Melissa Stambaugh, call to order was 1:00 p.m. Meeting was in the Commissioner's Conference room, Suite 4.

#### BUSINESS CONDUCTED AT THE MEETING

1. BUSINESS CONDUCTED: Discussion and approval of minutes of the July 1, 2022, regular meeting. Motion by Marak, second by Perna, minutes be approved. Marak, aye; Perna, aye; Stambaugh, aye. Motion passed 3-0.

- 2. BUSINESS CONDUCTED: Processed absentee mail in ballots for the August 23, 2022, Runoff Primary Election. After opening the outer envelopes and examining the affidavits for sufficiency, the board determined that a total of four absentee ballots must be rejected. ACTION TAKEN: Motion by Marak, 2<sup>nd</sup> by Perna to reject 1 ballot for lack of notary seal, 1 ballot for lack of Notary, 1 ballot for lack of witness or notary, and 1 ballot for lack of witness's addresses. Marak, aye; Perna, aye; Stambaugh, aye. Motion passed 3-0. While opening the affidavits we found that we needed to remake 2 ballots. ACTION TAKEN: Motion by Stambaugh, 2<sup>nd</sup> by Perna to remake 2 ballots. Marak, aye; Perna, aye; Stambaugh, aye. Motion passed 3-0. ACTION TAKEN: Motion by Stambaugh, 2<sup>nd</sup> by Perna to count remaining 126 ballots. Marak, aye; Perna, aye; Stambaugh, aye. Motion passed 3-0. The ballots were processed through the voting device by Marak, Perna and Stambaugh. The polls were suspended until August 23, 2022. At that time the remainder of the absentee ballots will be processed.
