MINUTES OF THE LINCOLN COUNTY ELECTION BOARD MEETING AUGUST 26, 2022


The Lincoln County Election Board met in a regular meeting at 3:30 p.m. at the Election Board Office, Suite 15, Lincoln County Courthouse, 811 Manvel Ave., Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on December 9, 2021, at 8:40 a.m. and by posting an agenda at the County Election Board office on August 24, 2022, at 9:30 a.m. One copy of the notice and one of the agenda is attached.


The following members were present: Anthony Perna, James Marak, Melissa Stambaugh

BUSINESS CONDUCTED AT THE MEETING

- 1. CALL TO ORDER** by Perna at 3:30 p.m. All members were present.
- 2. BUSINESS CONDUCTED:** Discussion and approval of minutes of the August 23, 2022, regular meeting. Motion by Marak, second by Stambaugh, minutes be approved. Roll call vote by Stambaugh: Marak, aye; Perna, aye; Stambaugh, aye. Motion passed 3-0.
- 3. BUSINESS CONDUCTED:** Process provisional ballots for the August 23, 2022, Runoff Primary Election. After Sec. Stambaugh researched 12 provisional ballots it was determined that 5 ballots should count. After opening the outer envelopes of 5 provisionals, Sec. Stambaugh ran the ballots through the escan voting device and tabulated the results and printed reports. There were 7 provisional ballots rejected for various reasons. ACTION TAKEN: None. Board action not required.



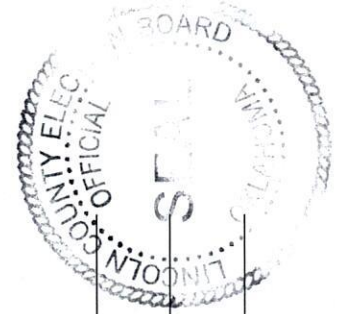


