## MINUTES OF THE LINCOLN COUNTY ELECTION BOARD MEETING


JUNE 28, 2022


The Lincoln County Election Board met in a regular meeting at 2:00 p.m. at the Election Board Office, Lincoln County Courthouse, Ste. 15, Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on December 9, 2021, at 8:40 a.m. and by posting an agenda at the County Election Board office on June 15, 2022, at 3:45 p.m. One copy of the notice and one of the agenda is attached.


The following members were present: Anthony Perna, James Marak, Melissa Stambaugh, all members were present. Call to order at 2:00 p.m.

### BUSINESS CONDUCTED AT THE MEETING

1. **BUSINESS CONDUCTED:** Discussion and approval of minutes of the June 25, 2022, special meeting. **ACTION TAKEN:** Motion by Marak, second by Stambaugh, minutes be approved. **ROLL CALL VOTE:** Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
2. **BUSINESS CONDUCTED:** Process mail and nursing home absentee ballots submitted for the June 28, 2022, Primary Election. **ACTION TAKEN:** The Board members opened outer envelopes and examined the affidavits for absentee ballots submitted by mail and by nursing home voters. The board remade 2 Uniform Services Ballots. The Board determined that all 19 ballots opened were sufficient, and ballots were processed through the voting device.
3. Marak made a motion at 3:05 to recess til no later than 6:45, and the 2<sup>nd</sup> was made by Perna. **ROLL CALL VOTE:** Perna, aye; Marak, aye. Motion passed 2-0. Stambaugh had left to take care of problem at precinct 21. Stambaugh was present when meeting was reconvened from recess. Marak motion, Stambaugh 2<sup>nd</sup> to reconvene. Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0. Reconvened at 6:45.
4. **BUSINESS CONDUCTED:** Board members were present and participated in the receipt of voting devices, election supplies and ballots from inspectors; the tabulation of election results and production of tabulation reports and summary result reports; and the transfer of transfer boxes to the sheriff for security. The Canvassing of the Primary Election for Federal, State, and County Candidates was done by the board for the June 28, 2022, Primary Election. **ACTION TAKEN:** None. Board action not required.
5. We discussed the Meeting to be held on July 1, 2022, at 3:00 p.m.
