## **MINUTES OF THE LINCOLN COUNTY ELECTION BOARD MEETING NOVEMBER 8, 2022**


The Lincoln County Election Board met in a regular meeting at 1:00 p.m. at the Election Board Office, Lincoln County Courthouse, Ste. 15, Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on December 9, 2021, at 8:40 a.m. and by posting an agenda at the County Election Board office on October 26, 2022, at 12:05 p.m. One copy of the notice and one of the agenda is attached.


### **BUSINESS CONDUCTED AT THE MEETING**


1. Call to order at 1:00 p.m. The following members were present: Anthony Perna, James Marak, Melissa Stambaugh, all members were present. Also present were 2 employees from the Legislative Office of Fiscal Transparency. The County Election Board Members welcomed them to the meeting.
2. **BUSINESS CONDUCTED:** Discussion and approval of minutes of the November 5, 2022, special meeting. **ACTION TAKEN:** Motion by Marak, second by Perna, minutes be approved. **ROLL CALL VOTE:** Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
3. **BUSINESS CONDUCTED:** Process mail and nursing home absentee ballots submitted for the November 8, 2022, General Election. **ACTION TAKEN:** The Board members opened outer envelopes and examined the affidavits for absentee ballots submitted by mail and by nursing home voters. The County Election Board Members determined that the remaining 17 ballots opened were sufficient, and ballots were processed through the voting device. Motion by Marak, second by Perna to count the 17 additional ballots received since the Meeting on November 5, 2022, for Mail and Nursing Home for the November 8, 2022, General Election. **ROLL CALL VOTE:** Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
4. Marak made a motion at 1:55 p.m. to recess till no later than 6:00 p.m., and the 2<sup>nd</sup> was made by Perna. **ROLL CALL VOTE:** Perna, aye; Marak, aye. Stambaugh, aye. Motion passed 3-0. Meeting reconvened at 6:00 p.m. Motion to reconvene at 6:00 p.m. by Marak, seconded by Perna. **ROLL CALL VOTE:** Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
5. **BUSINESS CONDUCTED:** Process any additional mail or faxed military absentee ballots submitted for the November 8, 2022, General Election. **ACTION TAKEN:** The Board members opened outer envelopes and examined the affidavits for additional absentee ballots submitted by mail. Motion by Marak, second by Perna to reject one absentee ballot for lack of witness address. **ROLL CALL VOTE:** Perna, aye; Marak, aye; Stambaugh,

aye. Motion passed 3-0. The Board determined that the remaining 1 ballot opened was sufficient, and the ballot was processed through the voting device. Motion by Perna, second by Marak to count the ballot for the November 8, 2022, General Election. Making a total of 331 General election absentee ballots and 34 Southwest Fire District absentee ballots counted. ROLL CALL VOTE: Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.

6. **BUSINESS CONDUCTED:** Board members were present and participated in the receipt of voting devices, election supplies and ballots from inspectors; the tabulation of election results and production of tabulation reports and summary result reports; and the transfer of transfer boxes to the sheriff for security. The Canvassing of the General Election for Federal, State, and County Candidates was done by the board for the November 8, 2022, General Election. **ACTION TAKEN:** None. Board action not required.
7. **BUSINESS CONDUCTED:** The board canvassed the returns for the Lincoln County Southwest Fire District # 1 General Election, November 8, 2022. **ACTION TAKEN:** None. Board action not required.
8. We discussed the date of the meeting to be held on November 11, 2022, at 3:00 p.m.
9. **MEETING WAS ADJOURNED** at 9:39 p.m. Motion by Marak, 2<sup>nd</sup> by Perna meeting be adjourned. Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
